

# RESEARCH DEGREES SCRUTINY PANEL

## 1. Terms of Reference

- 1.1 To scrutinise, and approve, all student applications for post-graduate research degrees through registration with partner Higher Education Institutions.
- 1.2 To scrutinise post-graduate research environment statements to be assured of a quality environment for research students in adherence to the research degrees codes of practice.
- 1.3 To monitor the timely progress of post-graduate research students through regular scrutiny of annual reviews, major review, and viva reports.
- 1.4 To identify thematic issues to be brought to the attention of the Research and Knowledge Exchange Committee in terms of post-graduate research degree student progress and/or environment issues.
- 1.5 To be responsible for the termination of registration where that is found to be appropriate in line with the research degrees code of practice.
- 1.6 To identify and approve appropriate research degree supervisor training and ensure the effectiveness of research degree supervision.
- 1.7 To be responsible for effective quality assurance in line with regulatory frameworks.
- 1.8 To liaise with Higher Education Partners Research Degrees Committees about any matters arising from the undertaking of the above duties.

- 1.9 To scrutinise, and approve, information, updates and reports related to the doctoral training partnership.
- 1.10 To ensure that the above duties are carried out with due regard to equality and diversity thereby avoiding discrimination.

## **2. Membership**

The Committee reserves the right to co-opt members for fixed term periods as appropriate.

- Director of Doctoral College (Chair)
- Three Post-Graduate Research Coordinators from Sport & Health, Education, and Business and Social Sciences
- Three research supervisors from the University's academic community from across discipline areas\*
- In attendance: Research and Knowledge Exchange Support Officer (Secretary)
- External advice will be sought via individual external feedback at relevant stages of the post-graduate research student life cycle in accordance with the research degrees code of practice

\*to serve normally for a period of two years with possible extension where appropriate at the Research and Knowledge Exchange Committee's discretion.

## **3. Frequency of Meetings and Conduct of Business**

- 3.1 The panel will organise to meet monthly. However, it will only meet as and when there is research degrees business to attend to, reporting to Research and Knowledge Exchange Committee via its minutes.
- 3.2 The quorum for the meeting will be 50% of the panel.

- 3.3 In his or her absence, the Chair may nominate the post-graduate research coordinator who sits on Research and Knowledge Exchange Committee to chair the meeting.
